

## Information clause on the processing of personal data (1% donors)

In performance of the obligation set out in *Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC* (Official Journal of the EU L 119 of 4.5.2016) - hereinafter referred to as General Data Protection Regulation, "GDPR", we hereby inform you that:

1. 2. Your personal data is processed in order for the Controller to send you a note of thanks for the donation of 1% of your tax to charity.
3. The legal basis for the processing of personal data is the Article 6(1)(a) of the GDPR in connection with your consent to transfer of your data to the Controller by the tax authority. Your consent to data processing may be withdrawn at any time, without affecting the lawfulness of the processing carried out on the basis of your consent given before its withdrawal.
4. Your personal data are processed in the following scope: name and surname, address, amount of donation, telephone number, e-mail address.
5. The recipients of your personal data may be local church communities and entities entitled to receive them on the basis of legal regulations.
6. Your personal data will be processed until you withdraw your consent to its processing.
7. You have the right to request from the Controller the access to your personal data, their rectification, erasure or restriction of processing and the right to data portability, as well as to lodge a complaint to the supervisory authority.
8. Your personal data were obtained from the tax authority.
9. Your personal data will not be used for automated individual decision-making, including profiling.
10. Consent to the processing of your image. I agree to the processing of my image (photographs) by "Dobro Czynić" Charitable Mission of the Church of Christ in the Republic of Poland with its seat in Warsaw (02-620) at 114/4 Pulawska Street for the purpose of their publication in social networks and the website.
