

Information clause on the processing of personal data (donors)

In performance of the obligation set out in Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (Official Journal of the EU L 119 of 4.5.2016) - hereinafter referred to as General Data Protection Regulation, "GDPR", we hereby inform you that:

1. Your personal data controller is "Dobro Czynić" Misja Charytatywna Kościoła Chrystusowego w RP ("Good Works" Charity Mission of the Church of Christ in the Republic of Poland) with its registered office in Warsaw (02-620) at 114/4 Puławska Street, email - biuro@dobroczyinic.pl.
2. Your personal data are processed for purposes related to the conclusion and execution of the donation agreement.
3. The legal basis for the processing of your personal data are: the Article 6(1)(b) of the GDPR, and the Article 6(1)(a) of the GDPR regarding your consent to the processing of your data for the purpose of sending you a note of thanks by the Controller. The consent given may be withdrawn at any time, without affecting the lawfulness of the processing carried out on the basis of consent given before its withdrawal.
4. The categories of processed data include: name and surname, bank account number and the donation amount, and - in the case of consent given data processing for the purpose of sending a note of thanks by the Controller - also the address, telephone number and e-mail address.
5. Recipients of your personal data may be local church communities and entities entitled to receive them on the basis of legal regulations.
6. Your personal data will be stored for the period of time necessary for the conclusion and execution of the donation agreement.
7. You have the right to request from the Controller the access to your personal data, their rectification, erasure or restriction of processing and the right to data portability, as well as to lodge a complaint to the supervisory authority.
8. Your personal data have been acquired directly from you or from an entity mediating the donation agreement.
9. Provision of personal data is necessary for the conclusion and execution of the donation agreement, failure to provide data results in the impossibility of its conclusion and execution.
10. Your personal data will not be used for automated individual decision-making, including profiling.
11. Consent to image processing. I agree to the processing of my personal data in the form of photographs (image) by "Dobro Czynić" Misja Charytatywna Kościoła Chrystusowego w RP ("Good Works" Charity Mission of the Church of Christ in the Republic of Poland) with its registered office in Warsaw (02-620) at 114/4 Puławska street for the purpose of their publication in social networks and on the website.
